This report outlines **Spruce** the Bruce Grants that may support the Chesley Community Working Group's goals.

Background

Bruce County's community development programs aim to build vibrant communities by supporting local businesses, municipalities, community partners, commercial areas and public experiences. Spruce the Bruce brings partners together to create a vision for future growth and development by providing tools and grants to achieve that vision.

<u>Analysis</u>

Spruce the Bruce grants may serve to support the work of the Chesley Community Working Groups goals. This report serves as a summary of grants that the municipality is eligible for.

Community Signage Grant

Community Signage helps to improve visitor's experiences, while showcasing the community's unique brand. May include Gateway signs, historical plaques, kiosk signs, route/trail markers. Funding: 50% of total project cost up to \$5,000

Streetscape Beautification Grant

Streetscape beautification projects help to make a community's downtown more attractive, distinctive to their unique brand, and pedestrian-friendly, helping to drive community vibrancy

and development. May include banners, benches, bike racks, greenspace enhancements, public art, seasonal decorations.

Funding: 50% of total project cost up to \$10,000

Destination Infrastructure & Active Transportation Grant

By upgrading and investing in local destination infrastructure around core local attractions, visitor experience is enhanced and increases the likelihood of return trips. Investing in active transportation projects also helps engage residents and visitors and encourages active means of transportation. May include capital improvements to public restrooms, parking areas, and lookouts.

Funding: 50% of total project cost up to \$2,500

Applications are accepted on a first come first serve basis early in the new year.
